Objective:

To build capacity of laboratory personnel or those working with environmental consultants on sampling for ambient air parameters (Particulate Matter and Gases) in line with requirements of ISO/IEC 17025:2017 & regulatory requirements and or NAAQS:-

- Installation of samplers for different objectives or customers requirements e.g Background pollution levels; Contribution from specific source of pollution; Air pollution from motor vehicles; study the effects of the presence of a constituent in the atmosphere, namely, health hazards, material damage etc.
- Making informed decision with regard to selection of external services— Purchase of equipment, Intermediate checks, Meteorological traceability etc.
- Understand basics of lab activities for ensuring Validity of Results including applicability; acceptance criteria
- Performing Intermediate checks, Functional checks, Lot blank check, Field blank check, Leak check including generating technical records
- Understanding basics for MU, decision rule in ambient air monitoring
- Processing of data and reporting the results
